Employee Purge	A new configuration setting has been added to automatically clear the Employee_HRISID when an employee is purged.	RND-684	
I-9 Form	The date pickers on the responsive Form I-9 have been extended to allow dates 60 years into the future. This matches the operation of the standard Form I-9 date pickers.	RND-1160	
Portal Studio	SilkRoad Onboarding portals now show a listing of all the tasks in an employee's event. With this addition, tasks available to be completed in the future are now displayed to employees.	RND-1501	
Reports	The Audit Report has been updated for the control by proxy feature. The Audit Report now allows filtering to view either all activity or only proxy activity. The API to collect the Audit Report has also been updated to allow similar filtering. The Audit Report API output has been updated to include the proxy user information; an XSLT has been added to the Manage Transformations page to maintain backward compatibility of the API output. Remove the XSLT to receive the new XML nodes.	RND-3238	
Security	There is a new privilege that lets users view and interact in SilkRoad Onboarding as another user in the system. This control by proxy feature improves troubleshooting and makes testing more efficient. Audit notes track the user account that was accessed and the user account that executed the actions.	RND-1405	
Task Management	A warning has been added to SilkRoad Onboarding when an employee attempts to complete a task that is not assigned to them. There is no change in the employee's ability to complete these tasks. Warning message: "The task that you are completing is assigned to another person. Are you sure you want to complete this task?"	RND-1162

Employee Record	Corrected an issue that prevented an employee from being retired when they were the assignee of a task that had been expired.	RND-277	
I-9 Form	Corrected issue where some text strings were not properly displayed when E-Verify is not enabled.	RND-1958	
Uploaded Documents	Addressed issue where some uploaded files were not being properly identified as images and were not included in download packages.	RND-3148

eForms	If a PDF that has a signing certificate applied is converted to a PDF/A format by SilkRoad, the signature will be invalidated because the PDF has changed. SilkRoad will need to prevent conversion of these PDFs. PDFs are converted in the UI by RND-1183 or the API by RND-1181	RND-2909
