Candidate Experience - Append Job Board Source Code to Job URL	OH-36969		For candidates applying to a job via the new Candidate Experience, we now track the candidates' source in the same way we are tracking the source for candidates who apply to a job via your existing career sites.
Candidate Experience - iOS zooming in on input fields	OH-37158		Made an improvement to the auto zoom-in feature in Safari on iOS, where you focus on an input and the screen zooms in, but when you clicked Done, the page did not zoom out. You had to manually zoom out.
Candidate Experience - Color Configuration updates	OH-37518		Made an improvement in the Candidate Experience Admin section for the button color setting so that now all buttons in the Candidate Experience display in whatever color the Admin user selected as the button color.
Candidate Experience - Add Button Text Color	OH-37529		We added a new Button Text Color option to the Manage Colors page in the Candidate Experience Admin Settings. Previously the Navigation Text Color also determined the button text color.
Candidate Experience - Long Portal Code Text	OH-37535		Made an improvement to the Career Site List page in Candidate Experience Admin so that portal codes with a lot of characters now wrap correctly on the page.
Presubmission Text needs to display when user sets up a Job Agent	OH-37845		If a pre-submission text is configured to display to applicants who submit their resume when applying to a job, then that same pre-submission text is now displayed to any candidate who is

GDPR - Accept Cookies Snackbar	OH-37946		<p>setting up a Job Agent on the career portal.</p> <p>You can now add a message about cookies being used on the career site. This message includes a link that can be configured to route the user to any policy that your company wants a user to review. The cookie policy message persists at the bottom of the screen until the user clicks the [Accept &amp; Close] button. After clicking that button, a cookie is created (valid for 30 days) during which time the user will not see this cookie policy message when using the same browser.</p> <p>Admin users with the ability to access the Settings page in the ATS can configure the display of the cookie policy message on a per portal basis.</p>
Candidate Experience - Customize Footer Links	OH-37961		<p>You can now add up to four columns with as many links in each column as you would like to have. We added a new "Manage Footer" page in the Candidate Experience Admin section. When configuring these columns, start by entering a column name first and then add as many links under that column as you need. For each link, you enter a Link Text, the URL, and decide if you want a new browser tab to open when the user clicks the link.</p>
Candidate Experience - Open Submission - Add 'Not Me' opt-out to 'Thank You for Submitting Your Resume' email	OH-37979		<p>We added the following sentence to the "Thank You for Submitting Your Resume" email that a candidate receives after submitting his/her resume as an Open Submission.</p> <p><i>If you did not submit your resume and feel that you have received this email in error, please click here to remove yourself.</i></p>
Candidate Experience - Career Site Options - UI Enhancements	OH-37982		<p>We removed the repetitive word "Configure" from the title of each of the available settings on the "Career Site Settings" page in the Candidate Experience Admin portal. We also added an icon behind each of the setting names.</p>

Candidate Experience - My Account - Send email for Open Submission recovery	OH-38006		<p>We added functionality that now sends a "Thank you for submitting your resume" email to the user who submitted his/her resume via an Open Submission. This email also includes the "Not Me" functionality, which allows the user to remove that Open Submission from their account.</p> <p>In addition, we added an "Open Submission" section to the "Your Profile" email, which displays the date the user submitted his/her Open Submission, as well as the "Not Me" link.</p> <p>We also created a new "Verify Your Email Address" page for when the user clicks the "Not Me" link, as well as a new removal confirmation page which displays after the user verified his/her email address.</p>
Candidate Experience - Configurable Footer Colors	OH-38029		<p>Now that we provided the ability to add a custom footer to the Candidate Experience, we also added the following color configuration options in the Candidate Experience Admin portal.</p> <ul style="list-style-type: none"> <li>Custom Footer Background Color</li> <li>Custom Footer Column Header Text Color</li> <li>Custom Footer Link Color</li> </ul>
Candidate Experience - Remove current ADMIN page in CX Admin	OH-38032		<p>We removed the "Admin" page from Candidate Experience Admin portal. That page only displayed one tile that routed the user to the Career Site List page, and it didn't provide any other functionality. By removing that page, and having the user now land directly on the Career Site List page, we removed an unnecessary step for any Admin user logging into the Candidate Experience Admin portal.</p>
Candidate Experience Admin - Career Site Settings - Make page headers/title consistent	OH-38039		<p>We made the wording of the labels of all the page headers throughout the Candidate Experience Admin portal consistent to provide a better user experience.</p>

Candidate Experience Admin - Career Site Settings - Colors - Change flash message for 'publish'	OH-38042		The confirmation message that displays once the user clicks the PUBLISH button after configuring the color options in the Candidate Experience Admin portal now reads "Changes saved & published successfully."
Candidate Experience - GDPR - Accept Cookies Snackbar	OH-38056		<p>We added the ability to add a message about cookies being used for the new Candidate Experience sites. This message includes a link that can be configured to route the user to any policy that your company would like the user to review. The cookie policy message persists at the bottom of the screen until the user clicks the [Accept &amp; Close] button. Upon clicking that button, a cookie is created that will be valid for 30 days, during which time the user will not see this cookie policy message when using the same browser.</p> <p>The configuration for this can be done in the Candidate Experience Admin portal, where we added a "Cookie Policy Acknowledgment" page that allows the Admin user to configure this on a per career site basis.</p>
Candidate Experience - Create setting for importing fields from ePostings portal	OH-38071		<p>We added a new setting in the Candidate Experience Admin portal that lets Admin users decide which version of the application form to use on a per career site basis. The options are:</p> <p>Display the default Quick Apply form, which only requires the applicant to enter his/her first name, last name, email address and upload a resume.</p> <p>Or import all the fields of the current career portal, which would include any configured custom fields, CQE questions, EEO &amp; OFCCP questions and work authorization questions.</p> <p>The import is an all-or-nothing type option. When selected, it will import all the fields currently used on the</p>

## Resolved issues

OH-37259		Fixed an issue on the Job Details page of the career sites where an empty space and an extra comma was displaying as part of the job location whenever the state was missing from the job location. In those instances, we now display "City Name, Country Name".
OH-37935		Fixed the resizing issue in the iframe version of recent jobs snippet. The iframe version of the recent jobs snippet was written to constantly update itself in height and width (every one second) so that when the browser resizes, the iframe adjusts to fit the content. This functioned correctly when you shrank the browser width. But expanding the browser width back out did not cause the iframe height to re-adjust back to a smaller height.
OH-38105	758967	Fixed an issue where decimal values entered into a Custom Field were converted into dates.
